

THE EU-MERCI PROJECT

EU coordinated **ME**thods and procedures based on **R**eal **C**ases for the effective implementation of policies and measures supporting energy efficiency in the **I**ndustry.

The overarching objective of EU-MERCI is to support, in a coordinated way, the growth of energy efficiency in industry processes. It will develop methods and tools for assisting EU industry in the effective implementation of energy efficiency improvements and in the monitoring of the energy savings, in application of the 2012/27/EU Directive.

The project will propose exemplary energy efficiency projects, common procedures and shared methods to assess and demonstrate the achieved energy savings and supporting tools to assist industries in effectively putting into practice energy efficiency improvements of the processes and in the technical/economic reporting of the savings, in application of the obligation schemes and/or alternative measures adopted in the respective MS.

EU-MERCI will help industry actors, who want to improve the energy efficiency of a process, to overcome experienced barriers; to maximize the technical and economic benefits; to simplify their burden in the preparation of possibly associated access-to-incentive demands.

The project will provide concerned evaluators with instruments enabling a more linear, uniform and, therefore, transparent evaluation of the demands.

Finally, EU-MERCI will support policy makers in the assessment of the effectiveness of the implemented efficiency mechanisms, giving also them a picture of the technologies and efficiency improvements to possibly incentive.

Open Conference of the project EU-MERCI

While presenting the framework of the EU policy in support of the Energy Efficiency of the industry processes, the Conference aims at introducing the innovative approach of the project EU-MERCI in order to foster the implementation of energy efficiency projects and facilitate the set-up of more effective support schemes.

A critical comparison of the different requirements fixed in EU28 by various obligation schemes and other efficiency measures according to the EED will be discussed, supported by an original in-field survey on barriers encountered in their implementation by industries and ESCOs.

EU-MERCI representatives will illustrate the methodology to identify and classify "Good Practices" of implementation of efficiency improvements and to assess actual savings and costs, basing on the real experience of monitored technological solutions in different industry sector.

Representatives of Italian industries associations will show experience, opportunities and trends on energy efficiency for the respective sectors and will discuss their expectations from the policy.
